The City of Paris's commitment

to facilitating access to the law began with the launch of a **free legal advice service** in the town hall of each arrondissement in partnership with the Paris Bar, and financed by the city authorities.

The city authorities are a member of the Paris Conseil Départemental de l'Aide Juridique (CDAJ – Departmental Council for Legal Assistance). It plays an active role in the work and activities of the Paris CDAJ and makes a significant contribution to its funding.

By way of example, financial contributions and contributions in kind made by the City of Paris and the Department of Paris for 2002 amounted to over €350,000 for the City of Paris and over €176,000 for the Department of Paris, i.e. 40% and 21% respectively of all contributions made by the members of the Paris CDAJ.

The city authorities have made a special commitment to implementing conventional systems and new local structures to meet the needs of the city's residents in relation to obtaining legal advice.

Access to Law points (PAD)

Points d'accès au droit (P.A.D. – Access to Law points) are free centres that allow residents, particularly the most underprivileged, to gain access to information in their own neighbourhood on their rights and responsibilities, as well as to assistance.

Please note! access to these surgeries is subject to :

List of areas of the law dealt with by these surgeries:

- Preventing evictions from rental properties for unpaid rent
- Information on the rights and obligations of owners and tenants
- Law relating to foreign nationals, asylum and access to French nationality.

Law and Justice Centres (MJD)

Maisons de la Justice et du Droit (MJD, Law and Justice Centres) work in the area of preventing and dealing with petty crime, the amicable settlement of disputes, organizing themed surgeries and specialized legal consultations. Law and Justice Centres fall under the responsibility of the Paris Tribunal de Grande Instance (the Regional Court of Paris).

Access to Law relay points (network)

Relais d'accès au droit or Access to Law relay points are neighbourhood legal information and guidance centres for people in difficulty.

Multi-service Information and Mediation points (PIMMS)

Points d'Information et de Médiation Multiservices (PIMMS - Multi-service Information and Mediation points) are organizations designed to stem the process of exclusion of the most vulnerable groups in urban districts and to facilitate access to public services.

The PIMMS are not intended to replace the administrative authorities or organizations authorized to process case files, however its officers can provide information to residents and help them find the right person to speak to, draft an administrative letter, fill out a form, and so on.

Paris Bar Solidarity Bus

Lawyers hold free, anonymous legal surgeries that guarantee users' confidentiality in the Paris Bar Solidarity Bus on the surgery days and locations.

City of Paris Mediation Service

All users are entitled to access the City of Paris Mediation Service in the event of a dispute with the Paris administrative authorities.

This procedure provides a mechanism for dealing with complaints from Parisians who are disputing a decision made by one of the departments at City Hall.
